Thank you for your email of 05/07/2021 concerning the overdue confirmation statement 11/05/2021.

As the company is required to remain on the register, the proposed strike off action has been discontinued. The failure to file a confirmation statement is a criminal offence but I will defer any prosecution action for 28 days from the date of this letter.

If the company record is not brought up-to-date by that time, the directors may face criminal proceedings. Conviction for this offence will result in a criminal record and a potential unlimited fine for each document not delivered on time.
